

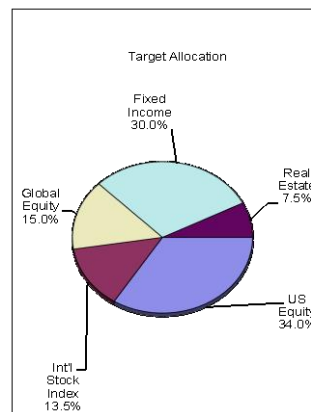
# INVESTOR SELECT FUND

## Investment

### Objective:

The Fund is invested with an asset allocation and investment strategy substantially similar to the investment allocations made for the Defined Benefit Plans. Currently, the asset allocation for the Fund is 62.5% stocks, 30% fixed income and 7.5% real estate.



### Investment Style:

The Fund consists of a mixture of some of the other investment choices available in the Plans as well as some additional investments. The target allocation for this Fund is shown in the pie chart at the right.
